in a fair and transparent manner, for passing of the Resolutions as mentioned under Item No(s). 1 and 2 as set out in the Notice of 37<sup>th</sup> AGM of the members of the Company dated August 12, 2020.

2. The management of the Company is responsible to ensure the compliances with the

requirements of the Act and Rules and General Circular Nos. 14/2020, 17/2020 and 20/2020 dated 8<sup>th</sup> April, 2020, 13<sup>th</sup> April, 2020 and 5<sup>th</sup> May, 2020 respectively, issued by Ministry of Corporate Affairs (MCA) (hereinafter referred to as 'MCA Circulars') relating to remote e-voting and e-voting during the AGM on the resolutions contained in the notice of AGM of the members / shareholders of the Company. Our responsibility as Scrutinizer for the remote e-voting and e-voting during the AGM is restricted to make a Consolidated Scrutinizer's Report of the votes cast 'in favour' or 'against' the resolutions stated in the said notice, based on the reports generated from the e-voting system provided by Central Depository Services (India) Limited (CDSL), the agency engaged by the Company to provide remote e-voting facility for e-voting and e-voting during the AGM.

- 3. The Company has confirmed to us that Notice dated August 12, 2020 alongwith Statement setting out material facts under Section 102 of the Act was sent by electronic mode on Monday, August 31, 2020 to shareholders whose e-mail id is registered with the Registrar and Share Transfer Agent / Company / Depositories in compliance with the MCA Circulars and SEBI Circular No. SEBI/HO/CFD/CMD1/CIR/P/2020/79 dated May 12, 2020. The said notice was dispatched on the basis of Register of Members made available by the Registrar & Share Transfer Agent of the Company and the list of beneficial owners made available by the depositories viz., National Securities Depository Limited (NSDL) and Central Depository Services (India) Limited (CDSL) as on Friday, August 28, 2020.
- 4. As per the provisions of Rule 20 of the Companies (Management and Administration) Rules, 2014, the Company had published advertisement about completion of dispatch of AGM Notice and providing remote e-voting facility in the English newspaper "Active Times" and Marathi newspaper "Mumbai Lakshdeep" on Tuesday, September 1, 2020.
- In terms of the aforesaid Notice, voting through electronic means was kept open for 3 (three) days from Tuesday, September 22, 2020 (09:00 a.m.) and ends on Thursday, September 24, 2020 (05:00 p.m.).
- The voting rights of members was considered in proportion to their shares in the paid up equity share capital of the Company as on the cut-off date i.e. Friday, September 18, 2020.
